LEASING AND TENANCY RULES, REGULATIONS AND POLICIES

I. Leasing Within the Association

- 1.1 Lessee Information: Owner must submit the following information to the Association prior to initiating a lease:
 - a. A blank copy of the lease form utilized by Owner for the lease;
 - b. The name, mailing address, phone number, and e-mail address of each person who will reside at a property in the subdivision under a lease;
 - c. The commencement date and term of the lease; and
 - d. The duration of the lease.
- 1.2 Fines: All violations are subject to a \$100.00 fine unless otherwise stated in the policies. All violations which are not cured within ten (10) days after the date of the violation notice which is sent to the responsible Owner/tenant will subject the Owner/tenant to additional fines and administrative fees until the violations are fully cured. The Board of Directors reserves the right to take any other legal action against any Owner to protect members of the Association from violation(s) of the policies or other governing documents, and/or to seek recovery of any amount owed.
- 1.3 Amendments: These Rules and Regulations are subject to amendment by a majority of the Board of Directors.
- 1.4 Effective Date: These Rules and Regulations shall be effective from and after the date of filing.
- 1.5 If any provision within these Rules, Regulations and Policies, or the application of any provision herein to any person or circumstance shall be held invalid by a court of competent jurisdiction, then such provision shall be stricken herefrom, and shall have no force and effect on any remaining provisions within these Rules, Regulations and Policies, which shall be read and enforced as if the stricken section had never existed.
